1) The organizations of the registered functional Primary Fishermen's Co-Operative Society Ltd., Fish Production Groups, Self-Help Groups connected to fishery activities and undertaking of fisheries department should possess ample initiative, Capacity for Organizational Expansion, Financial solvency and Goodwill.

Conditions/Important Instruction

- 2) The eligible registered functional Primary Fishermen's Co-Operative Society Ltd., Fish Production Groups, Self-Help Groups connected to fishery activities and undertaking of fisheries department must obey the Govt. Rules to participate in the auction.
- 3) The bid submitted by participating bidders of registered functional Primary Fishermen's Co-Operative Society Ltd., Fish Production Groups, Self-Help Groups connected to fishery activities and undertaking of fisheries department will be valid for period of 3 (three) years (15th April 2022 to 14th April 2025).
- 4) A) The minimum economic lease rent and earnest money for settlement of the Govt. Fisheries are shown in the list attached herewith. (Annexure "A")
 - B) The representatives of the participating bidders of registered functional Primary Fishermen's Co-Operative Society Ltd., Fish Production Groups, Self-Help Groups connected to fishery activities and undertaking of fisheries department should deposit Earnest Money amounting to 10% of the minimum economic lease rent as shown against each Govt. Fishery, in favour of SRO II & DDO DL & LRO OFFICE MURSHIDABAD, in IDBI Bank Account No. 0257104000671644 IFS Code IBKL0000257, MICR 742259002 to participate in the e-auction.
- 5) 25% of the accepted highest valid bid offer is to be deposited at the time of settlement and the remaining full amount of lease rent must be deposited within the following three (3) months, in one (01) installment only, failing which the earnest money of the highest valid bid offer submitted by the successful highest bidder, will be forfeited. In case of non-payment of full amount of lease rent for the first year, within three (3) months of the date of settlement by the lessee concerned, the said lease will be stand cancelled. In successive years also the lease rent of that year must be deposited in full prior commencement of that year (Bengali year). Otherwise the said lease will be cancelled and earnest money thereof will be forfeited with one month's notice.

Moreover, in that case if the second highest valid bidder is willing, will take settlement of the same for the remaining years at the bid value submitted by the highest bidder (1st year or 2nd year or 3rd year as the case may be) and continue fishery activities therein in the same conditions and so on. (For third valid bidder and so on).

- 6) The appropriate authority reserves full right to postpone, cancel or accept the entire Auction process of the Govt. Fisheries without assigning any reason.
- 7) After the settlement has been accepted by the Government, the highest valid bid offering registered functional Primary Fishermen's Co-Operative Society Ltd., Fish Production Groups, Self-Help Groups connected to fishery activities and undertaking of fisheries department will have to come to a written agreement with the Government.
- 8) Prior to the participation in the e-Auction the registered functional Primary Fishermen's Co-Operative Society Ltd., Fish Production Groups, Self-Help Groups connected to fishery activities and undertaking of fisheries department (if applicable) will have to submit documentary evidences in support of their claim that the entire arrear dues regarding Govt. Fisheries was paid by them, otherwise they will not be considered eligible for participation in the auction.

9) All the authorities of the registered functional Primary Fishermen's Co-Operative Society Ltd., Fish Production Groups, Self-Help Groups connected to fishery activities and undertaking of fisheries department must comply with all the Rules, norms and conventional procedures and restrictions, relevant to the settlement of the Govt. Fisheries and sub lease of any Govt. Fishery is strictly prohibited.

A lease deed is to be executed.

- 10) Mere participation in the e-Auction will not be considered as the only eligibility criteria in according settlement of Govt. Fisheries. If it is revealed that any registered functional Primary Fishermen's Co-Operative Society Ltd., Fish Production Groups, Self-Help Groups connected to fishery activities and undertaking of fisheries department is associated with any type of secret or illegal activities in respect of participation in the e-Auction, the said e-Auction will be considered as rejected forthwith.
- 11) The documents regarding production in respect of every year, in the subject Govt. Fishery must be submitted by the lessee concerned to the office of the ADF, Murshidabad at least 30 days prior to the beginning of the next year.
- 12) In case of River, Riverine and Cannel fisheries, the below stated conditions in pursuance of Memo No. 1321 dated 18.08.2017 of the office of the Executive Engineer, Berhampore, Irrigation Division must be followed strictly;

Conditions/ Important Instruction

- 'i) Any obstruction, construction, encroachment which is likely to interfere with, counteract or impede any public embankment on any public water course may be removed immediately as per Bengal Embankment Act 1882, rule -32 A.
- ii) Any obstruction / construction of navigable channel is not permitted and legal action as deemed fit may be taken against such body or corporate or person committed the offence as per law vide The Canals Act 1864 rule 15, 15 A , 15 B & 16.
- iii) Any person or persons willfully causes or aids in causing any obstruction to any line of navigation or any damage to the banks or works on such line of navigation shall be punished as per law in force vide The Bengal Waterways Act, rule-150."
