- 2. There should be three valid bidders to start the e-Auction process. In absence of the same the instant e-Auction would be treated as cancelled.
- 3. The allotment will be made to the bidder bidding the highest valid bid in such e-Auction process provided that the highest bid so obtained is higher than the minimum reserve price fixed for the same and subject to the approval and sanction of the District Magistrate and Collector.
- 4. Intending bidders must have **Digital Signature Certificate** (**DSC**) for e-submission of their bids online through Govt. e-Auction portal [ <a href="https://eauction.gov.in">https://eauction.gov.in</a>] and to participate in the competitive bidding online.
- 5. Relevant documents (listed below) should be uploaded with the bidding documents. Auction elapse time is maximum 5 (five) minutes and Auction Bid auto extension is also 5 (five) minutes.
- E-Auction shall be ascending forward in on-line electronic auction. Minimum incremental value is Rs. 1000/(One thousand) and maximum is 10% of reserve price.

- 2. The Value of material (213000 CFT x H1 Price quoted) must be paid by the successful (H1) bidder in one single installment by Bank Transfer within 24.09.2025.
- 3. After full payment, the proceedings will be forwarded to WBMDTCL for approval and the generation of e-Challan for transportation and sell of the material.
- 4. The Bidders workmen shall have to abide by the rules & regulations including public safety & security regulations of the relevant statutory Acts during lifting of the materials.
- 5. Neither the District Authority, Murshidabad nor WBMDTCL shall be in default because of the conditions constituting FORCE MAJEURE. Force Majeure shall mean any event or circumstances which effect or prevent performing the obligations in whole or part and which event or circumstances (i) is beyond the reasonable control and (ii) the affected party has been unable to overcome such event or circumstances by the exercise of due diligence and reasonable efforts, skill and care. - 6. The sand stock is offered for sale on AS IS WHERE IS basis EX WORKS OWNERS. Sand is sold on the assumption that the bidders have inspected the same and know what they are buying, irrespective of whether they have first inspected the materials or not. No complaint shall be entertained in this regard. After the submission of bid(s) by the Buyer, a presumption would be drawn that the buyer has inspected the material and has satisfied himself about the nature, quantity, quality, other technical specifications, taxes-duties and legalities prior to e-auction.
